AMENDMENT TO DECLARATION OF CYPRESS ISLAND, PHASE I, RECORDED IN BOOK 2252, PAGE 533 and SECTION TWO, RECORDED IN BOOK 2348, PAGE 21 OF THE NEW HANOVER COUNTY REGISTRY

THIS AMENDMENT OF DECLARATION OF CYPRESS ISLAND, PHASE I and SECTION TWO, said Declarations being recorded in Book 2252, Page 533, et seq. and Book 2348, Page 21 of the New Hanover County Registry;

WITNESSETH:

WHEREAS, the Declaration of Restrictions for Cypress Island, Phase I are recorded in Book 2252 at Page 533 et seg. of the New Hanover County Registry having been recorded on February 6, 1996; and the Declaration of Restrictions for Cypress Island, Phase Two are recorded in Book 2348, Page 21 of the New Hanover County Registry subjecting Phase Two to the Declaration of Phase I; and

WHEREAS, Article VII of said Declaration provides, among other things, that prior to December 31, 2004 the Declarant may amend the restrictions at any time without the consent of any lot owners.

NOW, THEREFORE, pursuant to and in compliance with Article VII of the Declaration of Covenants, Conditions and Restrictions of Cypress Island, Phase I recorded as referenced above are amended, as follows:

1. Article I, Section 2 is revised by removing the last sentence of the section and adding the following:

"In no event shall common area(s) be used for residential purposes. The upkeep and maintenance of the private roads and storm drainage system located within Cypress Island, to include all phases, shall be the responsibility of the homeowners association."

2. Article V, Section 5 is to be deleted in its entirety and replaced with the following:

"Section 5. All fences on any Lot shall be designed and constructed by Developer to its specifications. No alterations of existing fences shall be allowed without Architectural Review Committee approval."

3. Article V, Section 17, is amended by removing any reference to "Telfair Summit" and replacing it with "Cypress Island".

Except as amended hereby, the Declaration of Covenants, Conditions and Restrictions of Cypress Island, Phase I and Section Two as hereinabove referenced shall remain in full force and effect.
